Bamlanivimab Eli Lilly	Revocation of emergency use authorization	The FDA revoked the emergency use authorization for bamlanivimab, when administered alone, to be used for the treatment of mild-to-moderate coronavirus disease 2019 (COVID-19) in adults and certain pediatric patients with positive results of direct SARS-CoV-2 vial testing, and who are at high risk for progressing to severe COVID-19 and/or hospitalization. Bamlanivimab should be administered with etesevimab.
Diovan ® (valsartan) Novartis	Expanded indication	Treatment of hypertension, to lower blood pressure in adults and pediatric patients one year of age and older
Evekeo ODT™ (amphetamine sulfate) Arbor	Expanded indication, new strength	Treatment of attention deficit hyperactivity disorder in pediatric patients 3 to 17 years of age The FDA also approved a new strength (2.5 mg) of Evekeo ODT.
Farxiga® (dapagliflozin) AstraZeneca	New indication	To reduce the risk of sustained estimated glomerular filtration rate decline, end-stage kidney disease, cardiovascular death, and hospitalization for heart failure in adults with chronic kidney disease at risk of progression

COVID-19 Vaccine Johnson & Johnson	The CDC's Advisory Committee on Immunization Practices (ACIP) convened an emergency meeting to reassess the risk benefit profile of the Johnson & Johnson (J&J) coronavirus vaccine. After reviewing the current data, hearing from J&J, and deliberating on different options, the CDC decided to reaffirm their original recommendations for the vaccine for ages and genders. The J&J COVID-19 vaccine is recommended for persons 18 years of age and older in the U.S. population under the FDA's Emergency Use Authorization.
