COVID-19 vaccines	The FDA's Vaccines and Related Biological Products Advisory Committee unanimously voted for the 2023-2024 formula of COVID-19 vaccines in the U.S to include a periodic update of the current vaccine composition to a monovalent XBB-lineage.
Leqembi [™] (lecanemab-irmb) Eisai/Biogen	The FDA convened a Peripheral and Central Nervous System Drugs Advisory Committee meeting to discuss Eisai/Biogen's Leqembi for the treatment of early Alzheimer's disease. The FDA Advisory Committee reviewed Eisai's supplemental Biologics License Application to convert the accelerated approval to a traditional (full) approval.
RSV vaccines	The CDC's Advisory Committee on Immunization Practices voted to recommend that adults aged 60 years and older may receive a single dose of a respiratory syncytial virus (RSV) vaccine, using shared clinical decision-making based on risk assessment.

Contour[®] Next Gen Blood Glucose Meters Ascensia Diabetes Care	n/a	Recall	Ascensia Diabetes Care announced a voluntary consumer-level recall of specific serial numbers of one lot of Contour Next Gen Blood Glucose Meters due to potentially incorrect units of measurement. The recalled meters had incorrect factory-set units of measurement where the meters display glucose results in mmol/L rather than mg/dL.

Dronabinol and ziprasidone Major Pharmaceutical, Rugby Laboratories	dronabinol 2.5 mg capsules, ziprasidone 20 mg capsules	Recall	The FDA announced a consumer level recall of a single lot of Major Pharmaceutical's and Rugby Laboratories' dronabinol capsules and ziprasidone capsules. Some unit dose cartons labeled as ziprasidone 20 mg capsules were found to contain blister packages labeled as and containing dronabinol 2.5 mg capsules. Dronabinol 2.5 mg capsules may be in outer cartons that read dronabinol or ziprasidone. Ziprasidone is used for the treatment of schizophrenia, bipolar manic or mixed episodes, and as adjunctive therapy for the treatment of bipolar disorder. Dronabinol is used for the treatment of anorexia associated with weight loss in patients with Acquired Immune Deficiency Syndrome, and nausea and vomiting associated with chemotherapy.
Oxandrin[®] (oxandrolone) and oxandrolone Gemini, Upsher-Smith, Par, Sandoz	2.5 mg and 10 mg tablets	Withdrawal	The FDA announced the final decision to withdraw approval of brand and generic Oxandrin. The FDA believes a potential problem associated with oxandrolone tablets is sufficiently serious that the drug products should be removed from the market.
