

## Brassica Pharma – Recall of eye ointment products

- On February 26, 2024, [Brassica Pharma announced](#) a consumer level recall of multiple lots of eye ointment products (see chart below) because of potential lack of sterility noted during an inspection conducted by the FDA.
- The eye ointment products were distributed nationwide.

- These eye ointments are used to temporarily relieve burning and irritation of the eye and discomfort due to dryness of the eye or exposure to wind or sun, and as a protectant against further irritation.
- For those patients who use these products, there is a potential risk of eye infections or related harm. These products are intended to be sterile. Ophthalmic drug products pose a potential heightened risk of harm to users because drugs applied to the eyes bypass some of the body's natural defenses.
- To date, Brassica has not received any reports of adverse events related to this recall.

- Anyone with the affected lots on hand should stop distribution and return product. Patients who have bottles from the recalled lots of eye ointments should contact their pharmacy.
